



COOKIES POLICY

Cookies are files used as identification marks. KIP, as the Tpay service administrator, sends cookies via the Tpay website and stores them on users' hard drives. Our cookies are protected against being read by third parties using a standard web browser security system. We use two types of cookies:

- 1. short-term ("session cookies"), which are stored on the user's device and remain there until the end of the browser session and are then permanently deleted from the device memory;
- 2. long-term (permanent) cookies stored on the user's machine, where they remain until they are cleared by the user.

Depending on purpose, the following cookie files are gathered:

The purpose of cookies is to enable configuration of the displayed website, in particular:

- adaptation of website content to the preferences of the user and optimization of the use of personalized websites;
- recognition of the user's device and its location using Google Analytics (without linking these data to information about the user's IP address or other data);
- · displaying a properly formatted website, tailored to individual needs of the user;

- · collecting anonymous statistical information on visitors.

Consent may be given by users on their own and at any time by agreeing to this policy or by appropriately setting their web browser (using the appropriate setting configuration). If there are restrictions on the saving of essential cookie files, this may have an adverse effect on some of the features of Tpay service.

The user may delete cookies at any time using the available features in their web browser.

Cookies used by the KIP do not cause any damage to the user's computer or generate any configuration changes in the user's telecommunications device or software installed on that device.
